4. Approval of the NextGen RCS Board of Directors' Minutes for the Meeting of April 13, 2022.

- 6. Revenue/Billing Update (April 2022 June 2022)

- 7. Network Operations Update
 - 7.1 Monthly Reports (February 2022 March 2022) –Mr. Santiesteban reported the following updates:

April 2022: 3.95 million call setups with 25 busies. Average of 131,641 calls daily. 9 busies on the South San Diego Simulcast, 2 busies on the East San Diego Simulcast, 1 busy occurred in the West San Diego Simulcast.13 total busies at ASR radio sites, with 6 at Hendrix, and 7 at Calexico.

May 2022: 4.04 million calls made with 14 busies. Average of 130,334 calls daily. The busies were: 2 busies on the West San Diego Simulcast, 12 busies total at ASR radio sites with 6 each at the Hendrix and Calexico sites.

The busies are short intervals and the system is performing as it should. No major incidents to report this past quarter.

Discussion: Mr. Graham Mitchell inquired on how small the busies were compared to the calls and wanted to know if there is a national average or benchmark. Mr. Santiesteban mentioned that the busies is a fraction of a percentage vs. calls and busies take up one to two seconds depending on when the channel gets cleared. Mr. Santiesteban will get statistics for the RCS baseline vs. nationwide and will report on the next meeting.

8. Administrative Update

8.1 Training Update – Elissa Dorame reported the following training updates:

Classes: For FY21/22, 340 participants were trained, with 19 console classes and 14 field classes. 2 classes were completed in July and more classes are being scheduled. Ms. Tamra Samuels at Sheriff's Dispatch will continue to support in scheduling the classes as Ms. Dorame transitions back into program.

Trainers: Waiting for few more contracts with consultants to be completed and anticipate to be fully staffed with 9 trainers.

RCS website development: Targeted to be completed in September and it is the expectation that there will be more functionality and items available with the new website.

9. Major Projects Update

9.1 RCS Site Projects Status - Mr. Santiesteban reported the following updates for the 2021/2022 projects:

Project Milestones: Weed Abatement of 21 radio sites have been completed, anticipate remaining radio sites to be completed by end of month. Roof replacement at Volcan South is in-progress and anticipate completion by end of the month. Road repair at Banner Ranch is completed.

In- work: Generators for Sierra Rojo, Chihuahua, and Abbey in vendor's warehouse and waiting on Air Pollution Control District (APCD) permits for installation. Radio Site tours for RCS Board will be coordinated with Ms. Dorame for scheduling and implementation.

9.2 NextGen RCS Project Status – Mr. Santiesteban reported the following updates:

Project Milestones: San Ysidro and San Onofre final milestones completed. Subscriber re-programming: Completion of 58.3% programming on 10,047 portable radios and 4,045 mobile radios for a total of 14,092 programmed subscriber units out of 24,156 radios. All San Diego Sheriff's Department radios have been updated.

In-work: Subscriber re-programming for La Mesa PD is scheduled for next week. Code plug development ready to be generated for State CDCR, Brawley Fire, Police and Public Works, and Imperial Beach Lifeguards. For Black Mountain radio site update, met last week with landowners (AT&T PacBell) and working with County Real Estate on lease agreement to finalize building permit for tower. Channel expansion at Hendrix Peak proposal is reviewed and working with Motorola to execute change order.

Future plans: Subscriber re-programming for Federal fleet map pending approval. Working on DEA radio programming issues.

Phase 3: Current Balance for Phase 3 project is\$1.68M. Contingency balance is \$806K, for an overall project budget balance total of \$2.49M.

9.3 IVECA Projects: Mr. Mark Schmidt reported that IVECA experienced Heating, Ventilation and Air Conditioning (HVAC) failure at Brawley Green Road communication Site. Unit was replaced on an emergency basis. Microwave dish at Brawley Green Road site is running low due to date palm tree growth which is creating issues with the site's microwave path. Work on rectification is progressing.

Mr. Schmidt is working with RCS staff in developing plans for field user radio classes for both Motorola and Harris products. A Motorola POST class is scheduled at Imperial County Sheriff's Office for mid-August. Actively working with RCS Programming Team to get all radios re-programmed for Imperial County agencies.

10. Consent Agenda

- 10.1 Request the RCS Board approve the US Department of Veterans Affairs (VA) to increase their radio limit from 85 to 125 radios.
- 10.2 Request the RCS Board approve Viejas Tribal Security to become a mutual aid user for up to 10 radios.
- 10.3 Request the RCS Board approve Marine Corps Air Station (MCAS) Miramar Fire Department to increase their radio limit from 71 to 90 radios for mutual aid use.
- 10.4 Request the RCS Board approve Commander Navy Region Southwest to increase their radio limit from 45 to 100 radios for mutual aid use.

Mr. Jason Akbari discussed the following:

- 1) Mr. Ernie Fermin has moved on to another position and Caltrans is working on getting a replacement for RCS Board representative.
- 2) Caltrans is working on a statewide project for real live RF coverage map state highway system and is requesting for coverage map from RCS. Mr. Santiesteban will provide copy of the coverage map.
- 3) Coverage issue at Imperial County, past El Centro, Boulder Park, Truck Stop. Caltrans survey equipment confirmed coverage issue and inquired if there will be a plan to mitigate the coverage issue by RCS. Mr. Santiesteban will work with Mr. Schmidt on the location and discuss any probable solution.
- 4) No response from Mr. David Brooks regarding email request to survey area to see what frequencies will be used as control channel. Caltrans used own tools and relied on public information to move forward with their project to survey 40+ frequencies. Caltrans is requesting for open lines of communication in the future.
